
Holiday tree lighting in Ellison Bay

2015 Real Estate Tax Bills

The tax bills, both real estate and personal property, were mailed out of the Ellison Bay post office on Friday, December 4th. They were mailed to the address of record as of the middle of November. Some asked after that date to have them mailed to a different address and we have done the best we could to make the address changes. Your tax bill is also on the Door County web site, www.co.door.wi.gov. Follow the tabs that say land records and you can look at a summary of the taxes or you can see a copy of the actual tax bill that was created. For payments by credit card find Treasurer under departments and go to the bottom of his page.



The Town Hall office will be closed all day on Dec. 24th and Dec. 25th as well as Dec. 31st from noon on. Taxes can be paid at the hall on Dec. 31st from 1:00pm until 4:00pm. You can also pay your taxes at North Shore Bank or Associated Bank any time they are open.

DOG TAGS NOW AVAILABLE

We now have the 2016 dog tags available at the Town Hall. Dog tags need to be purchased every year and are required for all dogs in Liberty Grove. To receive a dog tag we will need to see a copy of your rabies certificate. The certificate needs to include the manufacturer of the rabies serum, the date give, the date expires and the serial number of the vaccine. If you have presented this information for previous years you will have to present it again as the licensing program we use drops this information each year. Your rabies certificate will be mailed back to you. The cost for the tag is \$3.00 if the dog is neutered or spayed or \$8.00 if not. There is a \$5.00 late fee added if not done by April 1st. Brushing in Liberty Grove

Clearing dead brush and other growth that is in the road right-of-way has begun. As long as weather permits the road crew is out and is working on the following roads:

Townline Rd – Hwy Q to Grove Rd Old Stage Rd-Hill to Woodcrest Robin Ln Scandia Rd-East of Old Stage Old Stage Ln Hill Rd-Hwy ZZ to Old Stage Rd Old Lime Kiln Rd- Townline Dr. to Hwy 57 Wildwood Rd-Old Stage Rd to Hwy ZZ Door Bluff Park Rd.

Brushing may not be done in this order but these are the roads scheduled from now until the spring. Please give the road crew room to work and use extra caution when near their equipment.

Snow Plowing and sand/salt

A reminder that snow plowing with resume shortly. Plowing or shoveling the snow into or across town roads is not permitted and can result in fines. If you have your driveway plowed by a private individual please remind them not to plow across town roads. We also have a mixture of sand and salt available at the hall. The cost is \$3.00 for a 5 gallon pail. You must supply your own pail. This is not available for commercial use.

Town Awarded LRIP Grant

The Local Roads Improvement Program (LRIP) was established in 1991 to assist local units of government in improving deteriorating roadways. Funding for this biennial program is provided through two continuing appropriations from the State of Wisconsin. Since its inception, the Town has received a total of \$115,135.66. A County Town Road Improvement Committee meets once the allocations are determined and calculates the amount to be awarded to each community based on various criteria, including longevity, size, safety, and traffic for the subject project. For the 2016-2017 biennium, the Town will receive \$20,000 for pavement replacement on Old Stage Road. The documents related to this process are on file in the Town office, and may be inspected during normal office hours.

Local government is very dependent on those willing to serve on various committees, commissions and citizens who come to the meetings both to learn about what is happening and offer their input. It is also difficult because at times friends and neighbors find themselves on separate sides of issues/situations that arise. Liberty Grove is certainly no different is this aspect and it is heartening to see we can resolve the differences in a civil and respectful manner.

As December winds down I would like to take this opportunity to thank all those who serve on the various Town Committees and Commissions. Your time, effort and concern for the wellbeing of our community are deeply appreciated.
