The first of the new "Welcome to the Town of Liberty Grove" signs are being installed on Highway 57 and Highway 42. In addition, signs are welcoming to Ellison Bay and Gills Rock. Pat Keenan Creed was the winner of a contest to design potential signs. It is hoped that the signage will make people aware of the entire Town and its "hamlets".

NWTC is progressing on the work to convert the old Bay Lake Bank building in Sister Bay into a Regional Learning Center for northern Door County. Current plans are to do the remodeling this winter/early spring and open by late spring or early summer. The core group of classes is in the development stage and more will be known closer to the opening of the Center.

Clerk/Treasurer Janet Johnson has noted that the first platted road in Liberty Grove was North Bay Rd. We plan to investigate the history of various Town roads as they are an integral part of our history and main recipient of Town tax dollars for maintenance.

It should be noted that the county has asked Liberty Grove to plow the road entering the County Park at Ellison Bluff. They have provided funding for the Town to use our pick-up truck to plow the road so as not to disturb the tree lined entrance as their equipment is too large to navigate the road. The Town has been providing maintenance service to the Park for many years during the seasons that the park is open.

There is ongoing discussion about the parking problem on Hwy 42 by Grandview Park. All solutions previously tried do not seem to alleviate the safety hazard during peak visitor times.

There has been more discussion on the plowing Ellison Bluff Park. The county has budgeted money, but can't do the work due to the fact that their plows are too large to keep from disturbing the tree lined road. The town crew will do the plowing until the fund is depleted.

It was decided to send an application to the state for grant money to build the Port de Mort stairway.
