It is a great time to visit Liberty Grove's 13 town parks. Our web site has our parks listed with a brief description of what they offer and how to get to them. Pack a picnic basket and head out while the weather is nice.

FROM YOUR TOWN CHAIRMAN

The Board is considering a Town wide service of garbage and recycling beginning in 2019. Additional information and refinements will be considered at the next Board meeting prior to making a final decision on the service. Data provided indicates a substantial savings for property owners over individual contract for service. In addition it is important to our efforts at providing an environmentally friendly community and anticipates future impacts on the Town infrastructure.

The new NWTC Innovation and Learning Center is up and running at the old Baylake Bank building in Sister Bay. It is a great opportunity for northern Door. If you or friends have not had an opportunity to visit the center please do so. Its success depends on our community support and utilization.

The road paving for 2018 has concluded and the chip sealing of certain roads will begin shortly. Administrator Kalms has pointed out that we are now able to pave more miles each year than in the past. We are no longer in the catch up process for road repair.

The Board has authorized administrator Kalms to seek engineering cost for the reconstruction of Waters End Road and Highway 42. This is an intersection that is difficult to see traffic on highway 42 approaching from the South from Waters End Road. There is also a water drainage issue in the ditch adjacent to 42. The Highway Committee will consider improvements in that area.

The Board received a progress report from Carol Ash on the Ellison Bay Beautification Project. The Town has requested approval of speed monitor locations from the DOT on Highway 42 approaches to Ellison Bay. The Board is appreciative of Carol and her committee in their continuing efforts to improve the safety and appeal of Ellison Bay.

A reminder that a permit is required for the discharge of fireworks within the Town. The Town and Fire Department need to sign the permit. Information and permits are available at the Town Office. Please abide by the rules and also be considerate of your neighbors when using fireworks.

The Board and Finance Committee will begin work on the 2019 budget in the upcoming weeks. Public informational sessions will be held in the fall to answer questions from the public. It is anticipated that a levy override will be necessary to continue the current services and improvements as we move forward. There is a complicated formula mandated by the State when determining the levy. We are anticipating no increases, out of the ordinary, in property taxes with a successful override. Please contact the Town Office with any questions regarding an override .

From your Town Board:

Board approval – The Board approved Julie Kingsbury as an election worker and a full sewer rate study for the Utility Dist. #1.

Open Book – This is an opportunity to speak with our Assessor if you feel the current Assessment of your property is incorrect. Appointments are required. Open Book will be on Aug. 4, 2018 from 11:00am until 1:00pm. Watch for more information on this process in the July Newsletter.
