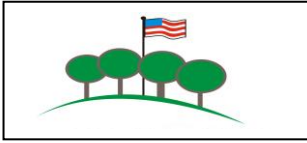

## From your Town Chairman

The Board has authorized the request for bids on paving and chip sealing roads for 2021. Mink River Road is the major project for this year and on recommendation from the Highway Committee will have two lifts of asphalt of 2 inches each. This was done due to the heavy truck traffic on the road. We normally pave with three inches of asphalt. The road will also be wider to allow for a bike/pedestrian lane adjacent to the shoulder. That will be delineated with lining to offer visual protection to those using the lane. It is anticipated this will be one of the most expensive road projects in years.

The Board is waiting for a report from Administer Kalms regarding companies that offer evaluating of facilities. This is part of our continued long-range planning and anticipation of needed budget considerations in the future. One building with particular need of evaluation, as it has been a point of discussion for years, is the Women's Club at the Ellison Bay Beach. It is not usable on a year-round basis and the kitchen area is very outdated. Discussions have centered around updating the building or possible replacement. Possible use of a public funding campaign is also under consideration as a way to help offset property tax funding.

A parcel of land adjacent to Port des Morts Park was considered by the Board but due to budget restraints and other projects the Board voted to not pursue the property purchase.

Still under consideration is the disposal of two structures on the Gills Rock Mariners Park property. The ad hoc committee is developing a plan for the property to present to Parks and Properties which will then be considered by the Board for implementation. It is anticipated the park will be done in stages.

The Wisconsin Towns Association monthly magazine has noted that Governor Evers proposed budget is "local government friendly" as it addressed many of the priorities of statewide town officials. Two provisions helpful to Liberty Grove are increased funding for Transportation Aids and Broadband expansion.

Personal Care Worker Certificate Program, 9am-3pm Tuesday, April 6,13,20, 27 and May 4. Tuition \$155.15, Textbook \$31.65.

This is a 30 hour, in person course combines lecture with practice of learned skills. The class meets for one 6-hour session per week for 5 weeks and is offered twice a year. All skill competencies are assessed under the guidance of a registered nurse. Successful students will receive a certificate.

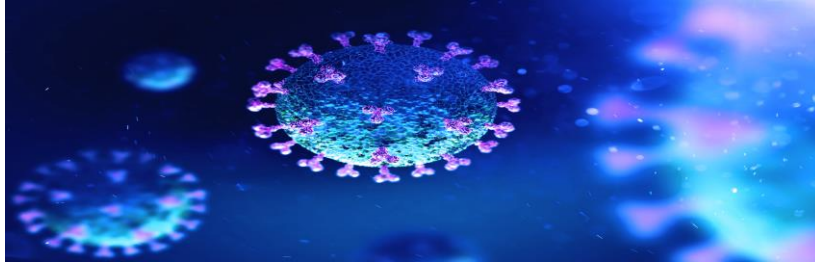

### Covid-19 Vaccination Side Effects

- The COVID-19 vaccination will help protect you from getting COVID-19. After your vaccination you may have some side effects, which are normal signs that your body is building protection. These side effects should go away in a few days. Some people experience sore arm, slight fever, or feeling tired, while others have no side effects at all. We recommend for best protection against COVID-19, to get both doses of the vaccine, even if you have side effects after the first dose.

Guidelines from Door County Public Health Department in regard to large group gatherings remain as follows:

Staying at Home	Gatherings Under 10 People	Gatherings of 10-50 People	Gatherings of 50 or more


Risk of COVID-19 spreading at events and gatherings increases as follows:

Lowest Risk	More Risk	Higher Risk	Highest Risk
Virtual-only activities, events, and gatherings.	Smaller outdoor and in-person gatherings in which individuals from different households remain spaced at least 6 feet apart, wear cloth face coverings, do not share objects, and come from the same local area (e.g., community, town, city, or county).	Medium-sized in-person gatherings that are adapted to allow individuals to remain spaced at least 6 feet apart and with attendees coming from outside the local area.	Large in-person gatherings where it is difficult for individuals to remain spaced at least 6 feet apart and attendees travel from outside the local area.
