

**TOWN OF LIBERTY GROVE  
ORDINANCE 7-13  
ESTABLISHING A BULKHEAD LINE AT HOTZ MEMORIAL TOWN PARK**

Whereas, the Town of Liberty Grove, Door County, Wisconsin, by and through its Town Board, proposes to establish in the interest of the public and pursuant to Section 30.11 of the Wisconsin Statutes, a new bulkhead line along a part of the shore of Lake Michigan, Door County, as hereinafter described, and does ordain as follows:

Section 1. That the bulkhead line of that part of the west shore of Lake Michigan, hereinafter described and more particularly shown by the attached map, is established and determined as set forth in the following description and the attached map, subject to the approval of the Wisconsin Department of Natural Resources, to wit:

*A proposed bulkhead line located in Government Lot 1 of Section 16, Township 32 North, Range 29 East, Town of Liberty Grove, Door County, Wisconsin described as follows:*

*Commencing at the northwest corner of said Section 16; thence N89°55'38"E -- 577.00 feet along the north line of said Government Lot 1 to a found stone marker; thence S00°04'22"E -- 22.40 feet to a found 1" steel pipe; thence N89°55'38"E -- 399.65 feet to the point of beginning of said bulkhead line; thence along said bulkhead as follow: S07°08'58"E -- 24.46 feet; thence S16°14'30"E 72.64 feet; thence S30°46'11"E -- 35.86 feet; thence S18°50'36"W -- 77.37 feet; thence S03°19'14"W -- 71.56 feet; thence S15°58'28"E -- 45.79 feet; thence S27°50'19"E -- 43.21 feet; thence S06°06'18"E -- 26.57 feet; thence S07°46'00"W -- 56.00 feet; thence S01°04'33"E -- 28.22 feet to the end of said bulkhead line.*

Section 2. That three certified copies of the ordinance, together with three true copies of such map, be submitted to the Wisconsin Department of Natural Resources for its approval.

Section 3. That upon the return receipt of such approved maps the same be filed with the following: *a.* Wisconsin Department of Natural Resources, *b.* Town of Liberty Grove Clerk/Administrator, *c.* Door County Register of Deeds for and in Door County, Wisconsin.

Section 4. This ordinance shall take effect upon passage and publication, according to law.
