

**TOWN OF LIBERTY GROVE  
RESOLUTION NO. 13-21  
ADOPTING MUNICIPAL WARDS**

WHEREAS, the Door County Board of Supervisors held a public hearing concerning the Preliminary County of Door Supervisory District Plan on September 21, 2021; and

WHEREAS, The Preliminary County of Door Supervisory District Plan was approved by the County Board on September 21, 2021; and

WHEREAS, the Preliminary County of Door Supervisory District Plan must be sent to Door County municipalities for division of wards; and

NOW THEREFORE, BE IT HEREBY RESOLVED by the Town Board of the Town of Liberty Grove, Door County, Wisconsin that the Preliminary County of Door Supervisory District Plan be and is hereby approved.

BE IT FURTHER RESOLVED that the Town of Liberty Grove establishes three (3) wards described as follows:

Ward One (1): Commencing at the Southwest corner of the Southwest one-quarter of the Southwest one-quarter of Section 30, T31N-R28E, thence Northerly along Town Line Drive to the Northwest corner of parcel 018-0-11933B being the Northwest corner of the Southwest one-quarter of the Southwest one-quarter of Section 19, T31N-R-28E, thence East approximately 417 feet along the Town of Liberty Grove Boundary Line to the Northeast corner of said parcel, thence Southerly to the centerline of Pioneer Road, thence Easterly along the centerline of Pioneer Road to the Southwest corner of the Southeast one-quarter of the Southwest one-quarter in Section 19, T31N-R28E, thence Northerly to the Northwest corner of the Southeast one-quarter of the Southwest one-quarter in said Section 19, thence Easterly to the Northeast corner of the Southeast one-quarter of the Southwest one-quarter in said section 19, thence Northerly to the center of said section 19, thence Westerly to the Southwest corner of the Southwest one-quarter of the Northwest one-quarter of said section 19, thence Northerly along the centerline of Town Line Drive to the intersection of Town Line Drive and Settlement Road, thence Easterly along the centerline of Settlement Road to the Northwest corner of the Northeast one-quarter of the Southwest one-quarter in Section 18, T31N-R28E, thence Northerly to the Southeast corner of the Northwest one-quarter of the Northwest one-quarter of said Section 18, thence Westerly to the centerline of Town Line Drive, thence Northerly to the shore of Green Bay, thence Easterly to along the shoreline of Green Bay to the centerline of Pebble Beach Road, thence Southerly along the centerline of Pebble Beach Road to the intersection of Pebble Beach Road and State Highway 42, thence Southerly along the centerline of Country Lane to the Southeast corner of the Southeast one-quarter of the Southeast one-quarter in Section 8, T31N-R28E, thence Easterly along the centerline of Flint Ridge Lane to the Southeast corner of the Southeast one-quarter of the Southeast one-quarter in said Section 8, thence Northerly along the centerline of Woodcrest Road to the intersection of Woodcrest Road and County Highway ZZ, thence Easterly along the centerline of County Highway ZZ continuing onto the centerline of Appleport Road to the shore of Lake Michigan, thence Southerly along the shoreline of Lake Michigan to the

Southeast corner of parcel 018-01-2744H located in Government Lot 4, thence Westerly along the Southern Town of Liberty Grove Boundary Line to the point of beginning.

Ward Two (2): Commencing at the Northwest corner of the Northwest one-quarter of the Northwest one-quarter in Section 4, T31N-R28E, thence Westerly to along the centerline of Hill Road to the shoreline of Green Bay, thence Northerly along the shoreline of Green Bay to the centerline of Cedar Branch, thence Southerly along the centerline of Cedar Branch to the centerline of Cedar Shore Road, thence Easterly along the centerline of Cedar Shore Road to the centerline of Garrett Bay Road, thence Southerly along the centerline of Garrett Bay Road to the intersection Lakeview Road and Mink River Road, thence Easterly along the centerline of Mink River Road to the intersection of Mink River Road and Dragonfly Lane, thence Easterly along the centerline of Dragonfly Lane to shoreline of Rodgers Lake, thence Southerly along the shoreline of Rodgers Lake to the shoreline of Lake Michigan, thence Southerly along the shoreline of Lake Michigan to the centerline of Appleport Road, thence Westerly along the centerline of Appleport Road continuing onto the centerline of County Highway ZZ to the Southwest corner of parcel 018-01-043C2, thence Northerly along the West Town of Liberty Grove Boundary Line to the point of beginning.

Ward Three (3): Commencing at the Southwest corner of the Southwest one-quarter of the Southeast one-quarter of Section 14, T32-R28E, thence Easterly to the centerline of Mink River Road, thence Northerly along the centerline of Mink River Road to the centerline of Lakeview Road, thence Northerly along the centerline to Lakeview Road to the centerline of Cedar Shore Road, thence Westerly along the centerline of Cedar shore Road to the centerline of Cedar Branch, thence Northerly along the centerline of Cedar Branch to the shoreline of Green Bay, thence Northerly along the shoreline of Green Bay following the Northern section of the Town Boundary Line into the Shoreline of Lake Michigan, thence Southerly along the shoreline of Lake Michigan to the West shoreline of Rodgers Lake, thence Northerly along the West shoreline of Rodgers Lake to the centerline of Dragonfly Lane, thence Westerly along the centerline of Dragonfly Lane to the point of beginning. Also including the island known as Gravel Island.

BE IT FURTHER RESOLVED that the Liberty Grove Town Hall, located at 11161 Old Stage Road in the Town of Liberty Grove shall be the official polling place for the Town of Liberty Grove Wards 1, 2 and 3 of the County of Door Supervisory District Plan.
