## FROM YOUR TOWN CHAIRMAN

An article by the executive director of the Wisconsin Towns Association magazine January issue indicates he is anticipating funding for local governments will increasingly become grant based. Liberty Grove has some experience in applying and receiving grants in the past. Our joining Bay Lakes Regional Planning coupled with also belonging to Door County Economic Development Corporation puts us in a good position to receive assistance in applying for grants when and if needed as we move forward with various projects.

Beyond our current efforts to expand broadband internet town wide, is the Mariner Park in Gills Rock. As stated previously the development and implementation of a plan for the park was targeted to be a three-to-five-year project. It is important to have in place a solid plan on how to finance these projects.

At the Special Board meeting on December 29, 2021, the board decided, at the suggestion of Supervisor Schwengel, to set excess room tax funds into the Fire Department Capital Reserve fund with the purpose to cover future costs of investments in equipment. Chris Hecht and his department have done an excellent job of anticipating replacement of various trucks in the future. This has also been done with our implementation of rolling five-year plans for anticipated funding by our various committees. Utilizing grants will certainly be part of our planning moving forward. In addition to our regular town legal services we have been working with the legal firm Boardman Clark from Madison. The board has utilized "closed sessions" which are allowed for a very limited set of purposes by State Statutes often with an attorney being part of the meeting. Normally the board will not make motions in the closed session but do so when back in open session. Administrator Kalms and Clerk Treasurer Bell have been very diligent to make sure the meeting follows that statute and is posted properly. Town meetings will continue to be held via Zoom. Those meetings are open to the public and instructions on how to attend are always listed on the posted meeting agendas. We follow the same meeting procedure as in-person meetings with the opportunity for public input.

# <u>Process for building a home or placing an</u> accessory building on your property

Many people call the office asking what the process is for adding structures to their property. Generally, speaking, the County deals with correct placement of structures on properties including well and septic and the Town deals with the actual construction of dwellings and accessory structures. The Town is under County Zoning so the first step is to go to the County Land Services department at 421 Nebraska St., Sturgeon Bay. Their phone number is 888-743-1844, ext. 2323. Once all permits are approved, you would then complete a Town of Liberty Grove building permit. The form can also be found on the Town website. Libertygrove.org

# Dog License 2022

The 2022 Dog Licenses & Tags for new dogs and renewals are as of December 1, 2021.

You must apply for the license before April 1, 2022, to avoid a late fee.

Fees are Altered - \$5.00


Regular - \$10.00

You will need to provide a certificate from your dog's veterinarian showing his/her current rabies shot, expiration date, and the manufacturer and serial number for that vaccine

**Covid Booster Information:** For those who received Johnson & Johnson COVID-19 vaccine, and are age 18 and older, a booster dose is recommended no sooner than 2 full months after receiving the first dose.

**Everyone who is 16 or 17 years old** is eligible to get a booster dose of **only Pfizer**, at least six months after their second dose of **Pfizer**.

For those who received Moderna or Pfizer COVID-19 vaccine, it is recommended that the following populations receive a booster dose of Moderna or Pfizer no sooner than 6 months after receiving their second dose of Moderna or Pfizer in order to further strengthen their immunity.

Everyone 18 years and older is eligible for the booster dose.

To further explain the 6-month timing, if you received your second dose of Pfizer or Moderna on May 14, for example, you are not eligible to receive your booster until on or after November 14.

Door County Public Health does not have the Moderna vaccine; some of the other COVID vaccinators in the community are able to provide Moderna. Currently, the Pfizer booster authorization only applies to people whose primary series was Pfizer vaccine. Please bring your vaccine card with you when you come to your appointment.
