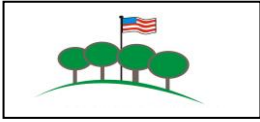

FROM YOUR TOWN CHAIRMAN

The Board has requested Nsight to proceed with posting an RFP for the Broadband Engineering Design study. Based on the receipt of the RFP for Baileys Harbor it is assumed the budgeted \$150,000 for the study will be exceeded due to higher costs and more miles of road in Liberty Grove. The firm hired by Nsight will need to travel on each of our roads to determine the amount of fiber optic cable needed, and whether the cable can be buried or strung along existing power poles. The board has reaffirmed its goal to install fiber optic cable town wide. Nsight works with various contractors and will receive their cost estimate and provide that information to the Town Board.

Administrator Kalms will be gathering updated estimates on a Facilities Assessment for town structures. That is scheduled for our next board meeting.

The board watched a Zoom presentation by Harmari STR. It is a Canadian company that monitors Short Term Rentals. The board requested that the firm provide us with a cost should we move forward with their company.

Joel Asher has been appointed to the Technology Committee. He will be replacing long time member John Dwonch on the committee. On behalf of the board and administration I extend our Thank You to John for his years of service on the committee.

Mike Repp has been appointed to the Parks and Properties Committee filling the spot vacated by Cheryl Culver when she moved to the Plan Commission.

Two Ordinances, Mailbox Policy and Speed Zones on Town Roads were adopted. Copies on the Ordinances are available on the Town Website.

Door County Bakery surrendered their Class B beverage license which was then acquired by Dovetail Grill. The bakery will continue to sell wine. Dovetail Grill is building a restaurant which will have a bar serving alcoholic drinks.

Defibs4DoorCounty Fact Sheet

What is the purpose of Defibs4DoorCounty?

- **Raise funds** to increase the number of automatic external defibrillators (AEDs) in key locations throughout the county and **help save lives**
- Match an anonymous \$75,000 donation to add approximately **80 new AEDs** to Door County's inventory
- Address an important **public safety need**:
 - For every minute that passes without CPR and defibrillation, the chances of survival decrease 7-10%*
 - Most cardiac arrests occur in public places are "shockable," making AEDs in public places vital*
 - Over 2 million people visit Door County each year**
 - 39% of Door County's year-round population is 60 or older***

When is the Defibs4DoorCounty Campaign?

- Fundraising now through Labor Day 2022
- Application process for AEDS is in two phases: February 1 for government agencies and April 1 for other organizations (see below)

Who Can Request An AED?

- Government agencies (police, fire, EMS and DNR, may submit applications for new AEDs starting February 1
- Schools, places of worship, theaters, & venues/businesses with large public gatherings) can apply starting April 1

How To Request An AED

 - Complete an AED request application
 - See guidelines required for receiving an AED
 - Request AED/CPR training
- All applications will be reviewed and prioritized by the Door County Fire Chiefs Association

Lake Michigan Lake Levels

Forecasted water levels for April 29th are below last year's levels on all lakes, except Lake Ontario, which is 20 inches above levels from a year ago. As the lakes continue in their period of seasonal rise, the water levels on Superior, Lakes Michigan-Huron, St. Clair, Erie, and Ontario, are 1 to 7 inches above water levels from a month ago. Lake Superior is near its long-term average for April, while all the other lakes continue to be above their long-term average April levels. In the next month, water levels on all lakes are forecast to rise by 1 to 4 inches. See our [Daily Levels](#) web page for more water level information.

Outdoor Fires

Small pre-built storage buildings If you are contemplating purchase of a pre-built storage building, you will need to check with the Land Use department at the government center in Sturgeon Bay for a zoning permit. Once a permit is issued there, check with the Liberty Grove building inspectors regarding a Town building permit. Certain requirements are in force for any structure greater than 200 square feet in floor area.

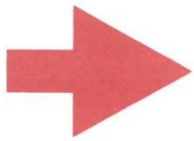

The main thing to remember is to locate the front of the box a minimum of 36 inches from the edge of the road pavement.
