#### FROM YOUR TOWN CHAIRMAN


The Town Annual Spring Meeting will be held on Tuesday April 18<sup>th</sup> beginning at 7pm in the Town Hall. In addition to the annual report from our accounting firm we have asked Nsight to provide an update on the proposed Town-wide fiber optic project. You may have seen FARR TECHNOLOGIES vehicles on Town roads. FARR, has six employees in Liberty Grove compiling the necessary data to be used for the design of the project. Once the design is completed and reviewed by Nsight and the Town, bids will be let on the construction phase. The engineering team from Nsight has started meeting with FARR representatives on a monthly basis discussing progress and any surprises that might arise. An update on that progress will be available at the Annual Spring Meeting. Farr has been invited to attend the Annual Meeting. Early indications are that the design should be done by late summer or early fall. Currently it is estimated that actual construction will begin in 2024 and barring any delays should be completed in 2024 as well. Grant monies, which have become very prevalent, will help cover a portion of the cost of the fiber optic project with the remainder, at this time, anticipated to a bond payable over a 20-year period. Administrator Kalms and Clerk/Treasurer Bell are developing various options for the final financing of the project. Nsight is monitoring the grant cycles and will apply for grants. Once an acceptable construction bid is known final decisions on financing will be made. Informational update meetings for the public will be held as we move forward. The Door County Housing Partnership has also been invited to the Spring Meeting. Our Economic Development Committee has been working on a possible attainable housing project for Liberty Grove. Destination Door County made a presentation to the Board on the Community Investment Fund. The fund will use room tax dollars generated by visitors to assist in paying for projects that benefit local residents and visitors. Examples could include public park improvements/expansions, public hiking or biking trails, public beach restorations, new restroom facilities. Applications must be for projects not yet started and could be part of an ongoing project like Mariner Park in Gills Rock and some aspects of the Town-wide fiber optic. Door Community Foundation is partnering in this fund and will accept/administer grants to gualified applicants that include Door County Based 501(c)(3) public charities, 501(c)(6) organizations and local units of government using a portion of room tax dollars paid by visitors. The Destination Door County board of directors anticipates committing up to \$1 million per year to the Community Investment Fund. While State Statutes require room tax dollars to be used in ways that benefit visitors. Grant applications must also demonstrate how it will improve the quality of life for local residents.

# Process for building a home or placing an accessory building on your property

Many people call the office asking what the process is for adding structures to their property. Generally, speaking, the County deals with correct placement of structures on properties including well and septic and the Town deals with the actual construction of dwellings and accessory structures. The Town is under County Zoning so the first step is to go to the County Land Services department at 421 Nebraska St., Sturgeon Bay. Their phone number is 888-743-1844, ext. 2323. Once all permits are approved, you would then complete a Town of Liberty Grove building permit. The form can also be found on the Town website. Libertygrovewi.gov Our building inspector is here on Thursday mornings from 8:30am to 10:00am. Appointments for other times are also possible. Call Door County Inspections at 920-495-1863.

#### 2023 Dog Licenses & Tags for new dogs and renewals are available.

You must apply for the license before April 1, 2023, to avoid a late fee. **Fees** are Altered- \$5.00 and Regular- \$10.00

You will need a certificate from your dog's veterinarian showing his/her current rabies shot, when that shot expires and the manufacturer and serial number of the serial number for the vaccine

# Pet Friendly Assisted Living

The majority of people love their pets because they enrich lives in multiple ways. About two thirds of households have various domestic animals in the United States according to research. Management of such retirement communities realizes that pets in the lives of aging individuals give them new meaning in life as well as enhance their well-being, so finding local pet friendly senior living communities is no longer a difficult task, whether you are looking for pet friendly nursing homes or assisted living homes.

#### **Benefits of Staying with Pets at Assisted Living Facilities**

Looking after the pets can help to ward off dementia symptoms. Learning how to look after a dog or cat, brushing them and learning how to train them are some of the things that keep neurons on their toes. The responsibility of looking after another living creature can also help to offer structure in seniors' daily lives.

#### **Physical Benefits**

**Increases Levels of Physical Activity** - staying with pets keeps retirees more active. Simple acts of looking after the lovely creatures such as walking them or cleaning and feeding them introduce an aspect of exercise in the owner's life, which is fantastic for their health.

**May Reduce Pain Levels**- because pet owners enjoy increased physical activity levels, it is possible that it can also help to reduce the pain that a person is experiencing. Increased physical activity associated with pet ownership also helps to lower pain that arthritis patients feel.

**Reduces Blood Pressure** - reduced stress levels that the pets evoke can lead to lowering/normalizing of blood pressure. Aging individuals who frequently interact with cats, dogs, or other animals are less likely to experience spikes in blood pressure than the ones who do not stay with their animals.

Help with Faster Healing - caregivers also observe that animal companions can help seniors to recover faster after they are taken ill and given permission to recuperate in their living spaces.

#### Social Benefits

**Improved Socialization** - pets can reduce the feelings of isolation in the elderly. Research reveals that people are more likely to smile more and interact with each other in the presence of dogs, cats and other animals. It goes to show that pet therapy evokes outgoing, social behavior and conversation.

**Reduced Verbal Aggression** - studies also show that elders with <u>dementia</u>, <u>Alzheimer's or other memory care</u> issues are less likely to experience verbal aggression if they are spending time with pets. It is safe to say that domestic animals have a positive influence on such populations.

**Judgement Free Friendships** - the friendships that retirees form with their pets are free of judgment and are pure. It is something that can make them feel better about themselves which can result in better self-esteem and self-awareness to enjoy brighter days in their new assisted living homes.
